

























<div>INSTRUCTIONS TO VOTER</div> <div>1. Use a BLACK pen.</div> <div>2. TO VOTE YOU MUST BLACKEN THE OVAL () TO THE LEFT OF YOUR CHOICE COMPLETELY. An oval () blackened to the left of the name of any candidate indicates a vote for that candidate.</div> <div>3. If you wish to vote straight party blacken the oval () to the left of your party choice.</div> <div>4. To cast a write-in vote for a person whose name is not on the ballot, blacken the oval to the left of the line provided and print the name in the blank space provided for that purpose.</div> <div>5. If you make a mistake DO NOT ERASE. Ask for a new ballot.</div> <div>6. REMOVE STUB before casting ballot.</div>
