

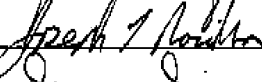
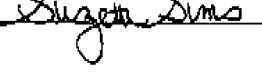

<p>INSTRUCTIONS TO VOTER</p> <p>1. Use a BLACK pen.</p> <p>2. TO VOTE YOU MUST BLACKEN THE OVAL (●) TO THE LEFT OF YOUR CHOICE COMPLETELY. An oval (●) blackened to the left of the name of any candidate indicates a vote for that candidate.</p> <p>3. To cast a write-in vote for a person whose name is not on the ballot, blacken the oval to the left of the line provided and print the name in the blank space provided for that purpose.</p> <p>4. If you make a mistake DO NOT ERASE. Ask for a new ballot.</p> <p>5.
