

Use a <b>BLACK</b> pen.</p> <p>2. <b>TO VOTE YOU MUST BLACKEN THE OVAL ( ● ) TO THE LEFT OF YOUR CHOICE COMPLETELY.</b> An oval ( ● ) blackened to the left of the name of any candidate indicates a vote for that candidate.</p> <p>3. To cast a <b>write-in vote</b> for a person whose name is not on the ballot, <b>blacken the oval to the left of the line</b> provided and print the name in the blank space provided for that purpose.</p> <p>4.
